Box 3

There were two major projects in 2018/9 – the replacement of the footpath from Rewe to Stoke Canon, and the provision of a helicopter night landing site in cooperation with Devon Air Ambulance.

The grants for this, totalling £16,402, were provided largely by Devon County Council, Devon Air Ambulance and East Devon District Council. In contrast no grants were sought or awarded in 2019/20. The only income being provided by the precept and a VAT refund of £4531.

Box 6

Spending in 2019/20 was significantly lower than in the previous year. The difference being a consequence of the large grants received in 2018/9.
